| Course Description | This course meets executive management level needs. The course is designed to meet the elements of NFPA 1021: <i>Standard for Fire Officer Professional Qualifications</i> and may lead to Pro Board and IFSAC certifications. Fire Officer IV will emphasize management of fire protection services to include Human Resource Management, Multi-Agency Emergency Service delivery with horizontal/vertical communication requirements and Risk Management. There will be group interactive exercises, which will reinforce class lectures. |
