Course Description	This course is based on NFPA 1001, Standard for Fire Fighter Professional Qualifications, The Volunteer Fire Fighter Certification course prepares the student for the Volunteer Fire Fighter State Certification Examination. The course is highly structured to provide academic information through a series of lectures and demonstrations augmented with visual aids. Practical skills are developed with a specified degree of proficiency through selected manipulative evolutions. Specific subject topics are building construction, emergency medical care, fire behavior, fire department communications, fire control, fire hose, fire preventions, and public fire education, fire streams, forcible entry, ladders, loss control, hazardous materials, orientation and safety, personal protective equipment, portable extinguishers, rescue and extrication, sprinkler and alarm systems, water supply, ventilation. This course is formatted into four individual blocks: Block 1, Block 2, Block 3 and Block 4 must be completed in sequence. When all blocks are satisfactorily completed within 24 months, the Alabama Fire College can issue an IFSAC and Pro Board Certificate. This course is recommended for all Volunteer Fire Fighters.
